MOTION: Karen Ladd, Sanborn Regional EA/Ben Dick, Manchester EA moved to amend the 2012-2013 NEA-NH Budget by increasing it \$200,000 which would increase the dues by \$15.80.

The NEA-New Hampshire will continue to assess new teachers' reduced state dues for the 2012-2013 school year.

The NEA-NH dues for teachers on the first and second steps of the salary schedule will be as follows:

First Step 60% of the active member dues Second Step 80% of the active member dues Third Step and beyond 100% of the active member dues

If a Collective Bargaining Agreement does not refer to steps on the salary schedule, this provision will apply to teachers as follows:

First year teaching (total yrs) 60% of the active member dues Second year teaching (total yrs) 80% of the active member dues Third year teaching and beyond 100% of the active member dues **MOTION CARRIED**

MOTION TO AMEND NBI #1: Lisa Reed, Manchester, EA/Sara Mantineo, Manchester EA, moved to amend NBI#2 to read that First Step would pay 80% of the active member dues and then go to 100% each step after.

MOTION: Judi Godbout, Manchester EA/Maxine Mosely, Manchester EA, moved to amend Article XII – Committees: 7. New Teacher Committee: Amend paragraph 7 of Article XII. 7 as follows:

7. Composed of up to 20 members, each with 10 five or fewer years of teaching experience, preferably two from each reason, to include new teachers, mentors and association members whose purpose is to: support new teachers and; facilitate transition from theory to practice; provided professional support for during their beginning years; encourage active members of the NEA-NH; and, develop future leaders of our professional organization. An A member of the Executive Board will chair the shall serve as a member of this committee. (2006)(2011)(2012)

MOTION: Doug Hoff, Oyster River TG/Richard Baker, Lin Wood EA, moved to amend Article IV Officers. 3. Elections and Terms, Amend paragraph 3.A.1, 2 and 3, by striking the word "mail" as follows:

- 1. The President and National Education Association Director shall be elected by mail ballot as set forth in Article IX-4. (2012).
- 2. The Vice President shall be elected by mail ballot as set forth in Article IX-4. The term of Vice President shall coincide with that of the President. (1983) (2012)
- 3. The Secretary/Treasurer shall be elected by mail ballot as set forth in Article IX-4. The term of the Secretary/Treasurer shall not coincide with that of the President and Vice President. (2001)(2012)

Paragraph 4: To be eligible to vote, active, student, educational support personnel and retired members shall be members by January 15 of the calendar year in which the election takes place. Appropriate ballots shall be made available mailed to the address of record by March 8. An envelope shall be provided that will have the address of a neutral party, selected by the Elections Committee printed thereon. Said ballots must be made available mailed. Ballots received after March 22 shall not be counted. (1987) (2012)

PROPOSED NEW RESOLUTION #1

MOTION: Evan Czyzowski, Sanborn EA/Doug Hoff, Oyster River TG, moved that the following new resolution be adopted:

Whereas TIAA-CREFF provides certain financial services for the members of NEA-NH and,

Whereas TIAA-CREFF benefits financially from their relationship with NEA-NH members and.

Whereas TIAA-CREFF has been providing members of the New Hampshire legislature with information regarding a defined contribution benefits retirement system which will replace the current defined benefit retirement plan for new public employees and,

Whereas the defined contribution plan proposed by the legislature will add \$1.2 billion to the Unfunded Accrued Liability in the retirement system and would further defund the current defined system to the point where closure of the current system would be a distinct possibility, and,

Whereas adoption of a defined contribution plan would be financially detriment to the financial best interests of current public employees and new hires and that TIAA CREFF's encouragement either directly or indirectly of the adoption of a defined contribution plan is not supported by NEA-NH Governance, NOW BE IT RESOLVED,

THAT the 2012 NEA-NH Delegates Assembly hereby goes on record as opposing the actions taken by TIAA CREFF and requests the NEA-NH Board of Directors to take whatever steps are necessary to communicate the Assembly's displeasure with TIAA CREFF and to request that TIAA CREFF cease and desist its involvement in the adoption of a defined contribution plan for public employees in the State of New Hampshire and further that the Board be empowered to take whatever steps it deems appropriate to enforce this resolution.
